1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2023-24 was £9.93 per elector.

In 2023-24, the Council made payments totalling £ 0 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

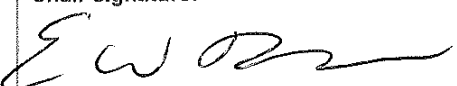

Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Pen-y-bont Fawr Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

- Assertion 3: Non-compliance with relevant laws and regulations. The Council has not published information it is required to publish electronically by the Local Government (Democracy) (Wales) Act. The Council has not published the previous years' annual returns (including the audit opinion) to their website.

Arrangements to secure economy, efficiency and effectiveness in use of resources

In my opinion, the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources:

- The Council's financial regulations state that the Council must obtain three quotations if a payment is between £100 and £3000. For a transaction tested, we could not evidence from the minutes reviewed of the Council attempting to obtain three quotations.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Approval of payments before payment

The Council's arrangements for making payments states that the Council must authorise and approve payments before making the payment. However, one of the transactions tested was paid before approval. We recommend that the Council comply with their arrangements for making payments.

Clerk's salary

Our audit testing identified a potential underpayment of salary to the Clerk.

We recommend that the Council reviews the payments made to ensure that the Clerk is paid in accordance with the contract of employment.

There are no further matters I wish to draw to the Council's attention.
